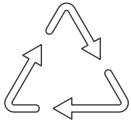
As many organisations aim to become environmentally compliant and seek ways to reduce their impact to the environment, they may look into:

Project management on environmental claims (catastrophic events and large and complex claims support)

Sedgwick (repair solutions - environmental) benefits of using our environmental services:

We manage our claims processes by using external approved consultants, contractors and suppliers. The process is as follows:

- 1 Using preferred suppliers and contractors of the insured (client) and as instructed by the policyholder
- 2 Suppliers and contractors in the local market, available to Sedgwick or its divisions (repair solutions - environmental) for rendering the required services in line with the insured's consent and requirements
- 3 External specialist suppliers, not under Sedgwick's agreed arrangements (external from Sedgwick's database – but supervised and controlled by Sedgwick)

In cases where the insured's preferred contractor or supplier cannot be engaged in an appropriate time frame, we have access to and can provide alternative options for consideration.

Repair solutions – additional services:

Sedgwick's repair solutions team provides an alternative, competitive restoration model to the insurance industry.
